**Proposed State Park near Strawn, Texas**

Texas Parks and Wildlife staff will brief interested citizens and receive comment regarding the planned acquisition of property for a new state park in the area at the Strawn school auditorium, 224 E. Walnut St., on Tuesday, August 23 at 7:00 PM. TPWD has been working for several years, exploring land in Johnson, Parker, Palo Pinto and Tarrant Counties and has identified a property near the town of Strawn as a potential site for a new State Park. Purchase of the site will fulfill a commitment to use the proceeds from the 2008 sale of the former Eagle Mountain Lake State Park property to acquire a new park in the Fort Worth area.

The identified site consists of three tracts totaling approximately 3,300 acres located a few miles north of Interstate 20, southwest of the town of Strawn. The property is rich in natural resources, with hills and two miles of the north fork of Palo Pinto Creek, which gives it excellent recreational potential.

Department staff will seek approval from the Texas Parks and Wildlife Commission at their August 25 meeting to acquire the acreage for future development and operation as a state park.

The Texas Parks and Wildlife Department Headquarters is located at 4200 Smith School Road in southeast Austin near Highway 71/Ben White Blvd., close to the Austin-Bergstrom International Airport (ABIA).Directions:

- Proceed south on IH 35, take Hwy. 71 east toward Bastrop and the airport.
- Exit Montopolis Drive and turn right on to Montopolis Drive (**NOTE:** the TPWD HQ sign).
- Proceed approximately ½ mile to the next intersection and turn left onto Burleson Road.
- Proceed ½ mile to the next intersection/light and turn right onto Smith School Road (**NOTE:** TPWD HQ sign on the corner).
- At the end of the road (Level 3 and Smith Elementary School on left side), **turn right** onto the winding road.
- Follow the winding road around the fenced enclosure to the Main two-story Headquarters Building.
- Parking is available on the left side of the main two-story building, properly marked as "Visitor Parking." The main entrance is the center of the main building that has the flag poles and the TPWD sign in front. Proceed into the main building to the Security desk; sign in and ask for your party.

### **Public Input Sought on Texas Outdoor Recreation Plan**

The TPWD Recreation Grants Branch is conducting a survey to determine the kinds of outdoor recreation activities in which Texas citizens participate and their opinions about outdoor recreation in the state. This survey will support development of the Texas Outdoor Recreation Plan (TORP) 2012-2017. Results will help TPWD identify outdoor recreation needs and guide funding opportunities through the federal Land & Water Conservation Fund and other grant programs. Anyone may complete the survey online at the 2012 TORP survey website from now through Sept. 26.
