#### **TPWD Announces 2014-2015 Legislative Appropriations Request (LAR) Facts**

Texas Parks and Wildlife Department submitted its Legislative Appropriations Request for the 2014-2015 biennium to the Legislative Budget Board on Aug. 23. TPWD's base budget for 2014-2015 is proposed to stay about the same, incorporating reductions required by the legislature for 2012-2013.

In the Legislative Appropriations Request, the agency is asking for increased funding for 2014-2015 in the form of six Exceptional Items totaling about \$103 million. These include, in two-year biennial totals:

- 1. \$18.9 million for state park funding needed to maintain current operations. Without this additional funding, at 2014-2015 base budget levels TPWD anticipates closing up to 20 state parks and one regional office and cutting 126 FTE employee positions.
- 2. \$11.9 million to restore capital budget reductions for vehicles, equipment and information technology
- 3. \$40 million for capital repair and construction at state parks, wildlife management areas, fish hatcheries and other TPWD facilities. Would be funded in large part with \$32 million in general obligation bond proceeds
- 4. \$13 million to restore fish and wildlife funding for habitat management and research, enhanced hunting and wildlife-related recreation, landowner technical guidance, inland and coastal fisheries management and hatchery operations
- 5. \$15.5 million to restore funding for local park grants to cities, counties and others
- 6. \$3.7 million to manage state Data Center cost increases and fund Information Technology capital needs

Alongside the LAR, TPSD provided a required schedule of reduction options totaling 10% of general revenue related funds, about \$36.8 million. These are not proposed cuts; they are options for lawmakers to consider as they balance the state budget. All figures are two-year totals:

- 1. \$16.9 million eliminate funds transferred to the General Land Office for coastal management and erosion projects
- 2. \$200,000 reduce Inland Fisheries hatchery production by about 30 percent
- 3. \$1 million eliminate all short term leases and cut in half long term leases on private land for public hunting
- 4. \$573,000 eliminate various wildlife research contracts
- 5. \$1.5 million decrease Coastal Fisheries hatchery production by about 33 percent
- 6. \$3.6 million suspend the next game warden cadet class
- 7. \$13 million close multiple state parks, reduce state park services

"Some caches are easy, while others more difficult to find. It really gives you some flexibility when you pick your adventure for the day. #### Big Bend Ranch SNA and Surrounding Counties Become the Home of New Butterfly Species

The *Strymon solitario* was recently described and studied at the Big Bend State Natural Area, and in surrounding counties, such as Presidio and Brewster, located in West Texas. The newly described *Strymon solitario* Texas butterfly was named after "The Solitario" rock formation that can be seen straddling the county line between Presidio and Brewster counties at Big Bend Ranch SNA. The *Strymon solitario*, also known as the Big Bend Scrub- Hairstreak, have been recorded before in the Big Bend area as early as October 1944. Majority of the records collected on this species were during late March-April and also again in September.
